International Competitive Bidding: The Ministry of Health of Cape Verde acting through the Department of Studies, Planning and Cooperation (hereinafter GEPC) invites potential bidders to place their bids for the supply of Goods and Related Services intended for five (5) Health Centers built under the "Construction and equipment of five health centres" project and located in Maio and Boavista (Islands), Santa Cruz and Tarrafal (Santiago Island municipalities), and Mosteiros (Fogo Island municipality).

Eligible bidders

This ICB Invitation is open to all bidders /suppliers /contractors /concessionaires either a natural person, private entity, government-owned entity or any combination of them with a formal intent to enter into an agreement or under an existing agreement in the form of a joint venture, consortium, or association that might include a local firm. Bidders are requested to observe the highest standards of ethics during the procurement and the execution of contracts. A Bidder shall not have a conflict of interest.

Source of funds: Government of Cape Verde and OPEC Fund for International Development.

The Bidding shall be governed by the OPEC Fund for International Development guidelines and the law, regulation, ordinance, order or bylaw having the force of law enacted, promulgated, abrogated, or changed in the Purchaser's country.

BID SUBMISSION

The Bids (1 original and 3 copies) in separate sealed envelopes, must be received by the Department of Studies, Planning and Cooperation (GEPC) headquartered in *Palácio do Governo, Várzea, Cidade da Praia* the capital city of the Republic of Cape Verde, within normal working days, Monday through Friday from 09:00 through 15:00.

The deadline for bid submission is until September 28th, 2010; Time: 14:00 local time. The opening of bids shall be at the same date and place; at 14:15 Hrs. Potential bidders should visit the United Nations and /or the Ministry of Health of Cape Verde websites to access the definitive bid documentation, have it printed, against the payment of 20000 escudos or the equivalent amount in Euros¹. Evidence of due payment shall be submitted to the address specified above.
